The Project consists of modifications to the TCSD collection system. The section of the collection system is in Tuolumne, California, south of Tuolumne Road North and north of Willow Avenue. The Project will have Base Bid work items and additives bid items. Base Bid items are the following: mobilization and demobilization, installation of 6-inch and 8-inch PVC Pipe, abandon existing pipe, pavement and surface restoration, manhole rehabilitation, abandon existing manholes, install manholes, install cleanouts, abandon existing cleanouts, install trench dams, compaction testing, reconnect sewer services, relocate sewer laterals, install grinder pumps, traffic control, and all other costs associated with the base bid portion of the project.

Additive bid items include, in ascending numerical sequence for bid comparison: A: Gardner) Site; and C: Madrone) Site. Bids will be received for a single prime contract.

The Contract base bid price of your Contract is Two Million, Nine Hundred Eighty-Seven Thousand, Seven Hundred and Thirty-Four Dollars (\$ 2,987,734) and Alternative item A. (\$ 143,274) and C. (\$ 425,405) totaling Five Hundred Sixty-Eight Thousand, Six Hundred and Seventy-Nine Dollars (\$ 568,679).

The Contract Price of the awarded Contract is Three Million, Five Hundred Fifty-Six Thousand, Four Hundred and Thirteen Dollars: (\$ 3,556,413)
