VI. Discussion/Action: The formation of a Tuolumne Township Community Service District (20 mins max)

The Local Agency Formation Commission (LAFCo) staff has stated that a "Tax Sharing" agreement is required between Tuolumne County, Tuolumne City Sanitary District (TCSD), and the Tuolumne Park & Recreation District (TPRD) in respect to the formation of the Tuolumne Community Services District, even though no taxes are being exchanged between the parties. John Feriani and I met with LAFCo representatives on this and other issues on August 30, 2022. In addition, the District needs to resolve the transfer of the Tuolumne Lighting District to the new Tuolumne Community Services District (CSD). The TPRD has scheduled this issue for their September 14, 2022 and I will be attending.

MOTION: Director Feriani moved approve the agreement between Tuolumne County, Tuolumne Park & Recreation District and Tuolumne City Sanitary District in respect to the formation of the Tuolumne Community Services District. Director Hart seconded and the motion carries by the following vote:




VIII. Director Feriani adjourned the meeting at 2:35 PM.
