**A RESOLUTION OF THE BOARD OF DIRECTORS OF THE
TUOLUMNE CITY SANITARY DISTRICT
AUTHORIZING A FINANCIAL ASSISTANCE APPLICATION WITH THE STATE WATER
RESOURCES CONTROL BOARD UNDER THE STATE REVOLVING FUND (SRF)
PROGRAM FOR THE WASTEWATER TREATMENT PLANT PROJECT – PHASE 2 AND
DESIGNATING AN AUTHORIZED REPRESENTATIVE FOR THE DISTRICT**

WHEREAS, the Tuolumne City Sanitary District (the "Entity") desires to construct and/or reconstruct certain public facilities and improvements relating to its Wastewater Treatment Plant, including certain treatment facilities, clarifiers, sludge treatment facilities, headworks equipment, pipelines, pumps, outfall facilities, lift stations, control systems and other infrastructure and/or facilities (the "*Treatment Plant Project – Phase 2*"); and

WHEREAS, the Entity intends to pay for the construction and/or reconstruction of the *Treatment Plant Project – Phase 2* or portions of the *Treatment Plant Project - Phase 2* with moneys ("Project Funds") provided by the State of California, acting by and through the State Water Resources Control Board (State Water Board); and

WHEREAS, the Board of Directors finds that the *Treatment Plant Project – Phase 2* is necessary to improve operating efficiency, reduce overall operating costs and to comply with regulatory requirements; and

WHEREAS, it is necessary and desirable to designate an Entity representative to act on behalf of the Board of Directors in signing and submitting various applications, agreements, requests, reports and other information required by the State Water Board; and

WHEREAS, the Board of Directors designates the General Manager as the *Authorized Representative* as indicated below.

**NOW, THEREFORE, THE TUOLUMNE CITY SANITARY DISTRICT DOES HEREBY
RESOLVE, ORDER AND DETERMINE AS FOLLOWS:**

The General Manager (the "Authorized Representative") or designee is hereby authorized and directed to sign and file, for and on behalf of the Entity, a Financial Assistance Application for a financing agreement from the State Water Resources Control Board for the planning, design, and construction of the *Treatment Plant Project – Phase 2*.

This Authorized Representative, or his/her designee, is designated to provide the assurances, certifications, and commitments required for the financial assistance application, including executing a financial assistance agreement from the State Water Resources Control Board and any amendments or changes thereto.

The Authorized Representative, or his/her designee, is designated to represent the Entity in carrying out the Entity's responsibilities under the financing agreement, including certifying disbursement requests on behalf of the Entity and compliance with applicable state and federal laws.
